**Beth Lucey** is a Deaf Massachusetts native from all-hearing family. Her educational background included a self-contained class, mainstreaming programs and Clarke School for the Deaf. She graduated from Gallaudet University twice: in 1997 with Bachelors degrees in ASL, Deaf Studies and Psychology and in 2002 with Masters degree in Interpretation, both with honors. She was the fourth Deaf person to complete MAI requirements and the first Deaf to win the Ron Coffey Excellence Award in Interpretation, the department's highest award. She completed a yearlong intensive mentorship program with Gallaudet Interpreting Service and maintained RID certified status since July of 2000. She currently works as a full time freelance CDI within the Commonwealth.

**John K. Monahan** graduated from Clarke School in 1978 and Newton North High School in 1981. He obtained AAS degree in Data Processing from NTID and Bachelors degree in Physical Education from Gallaudet in 1992. He was awarded Masters dearee from Boston University. Currently he teaches at

The Learning Center for the Deaf (TLC) for the last 18 years. He's been CTE teacher since 2011 and Driver Ed teacher since 2010. He has Deaf parents, Deaf sister and have two Deaf children that goes to TLC now.

Sheri Hostovosky works at the Center for Living & Working, Inc as a Deaf Skills Trainer, teaching independent living skills to Deaf and Hard of Hearing Parents and their children. She have been involved with substance abuse recovery in the Deaf Community since 1997. She was also a volunteer counselor for the Rape Crisis Center of Central Massachusetts, as well. She has extensive training in Domestic Violence prevention and one of her goals is to become Volunteer Advocate for Deaf and Hard of Hearing survivors. She currently serves as a board member for our Deaf Sisters Centers, an organization that works with Deaf and Hard of Hearing people affected by Domestic Violence.

Jessica Meehan works as a Child Care worker for Walden School located at the Learning Center for the Deaf. She have been involved with substance abuse recovery in the Deaf Community since 2010. She currently is serving as secretary for the Massachusetts State Association for the Deaf, a statewide non-profit organization that specializes in advocacy and protection of the rights and needs of Deaf and Hard of Hearing people. She hopes to return to school to earn both bachelors and masters degrees in Mental Health with an emphasis in drug counseling.
